Restricted Stock Award granted under the Issuer's 2014 Equity Incentive Plan vests as follows: 25% shall vest annually upon the first

(1) anniversary of the vesting commencement date of November 24, 2014 for the first two years with the remainder vesting in equal semi-annual installments every six months for the remaining two years.

(2) 25% of the shares subject to the stock option vest and become exercisable on November 24, 2015, and the remaining shares subject to the stock option vest and become exercisable in 36 equal monthly installments thereafter.
