- (1) No conversion or exercise price applies. Under the terms of the Stock Incentive Plan (SIP), a restricted stock unit converts to a share of common stock on the applicable vesting date.

This total includes the 01/26/2012 grant of 35,420 restricted stock units, 01/24/2013 grant of 33,360 restricted stock units and the 01/23/2014 grant of 37,180 restricted stock units, plus in each case, the incremental addition of restricted stock units credited to the original grant in amounts equal to dividend equivalents deemed earned on shares underlying such restricted stock units, and the 01/22/2015 grant of 33,210 restricted stock units.
