- (1) Each Share of Class A Common Stock was issued upon conversion of one share of Class B Common Stock.

- (6) One forty-eighth (1/48th) of the Shares subject to the Option vested on the date that is one month after the Vesting Commencement Date 2/11/2014 and one forty-eighth (1/48th) of the Shares subject to the Option vests each month thereafter on the same day of the month as the Vesting Commencement Date.

One forty-eighth (1/48th) of the Shares subject to the Option vested on the date that is one month after the Vesting Commencement Date 4/15/2014 and one forty-eighth (1/48th) of the Shares subject to the Option vests each month thereafter on the same day of the month as the Vesting Commencement Date.
