Mr. Traber no longer serves on our Board of Directors as a result of his decision to not stand for re-election at the Company's Annual Shareholders' Meeting held May 24, 2018. Accordingly, 12,000 unvested restricted shares are forfeited. Such shares originate from his restricted stock award of 24,000 shares dated May 16, 2013, of which 6,000 had previously vested and 6,000 had been cancelled.
