WBM is controlled by William Bradford Mosing, in his capacity as managing member of WBM's general partner. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by WBM, except to the extent of his pecuniary interest therein.

(3) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$7.25 to \$7.42, inclusive.

(4) The 25,226 shares reported are owned directly by the Trust u/l/w Janice P. Mosing f/b/o Victoria R. Mosing, of which William B. Mosing is the trustee. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.

(5) The 25,226 shares reported are owned directly by the Trust u/l/w Janice P. Mosing f/b/o Jaclyn E. Mosing, of which William B. Mosing is the trustee. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.

(6) The 39,145 shares reported are owned directly by the By-Pass Corporate Stock Trust u/l/w Janice P. Mosing f/b/o William B. Mosing, of which William B. Mosing is the trustee. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.
