(1) The Restricted Stock Units ("RSUs") granted on 08/22/2014 automatically vest 25% on each of the first four anniversaries of the date of grant. 1,401 RSUs, that included accrued dividend equivalents, vested on 08/22/2018 and were paid out in the form of Republic Services, Inc.'s common stock.

(2) Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the automatic vesting of 1,401 shares under a Restricted Stock Unit award on 08/22/2018. The fair market value of the exchanged shares was \$73.26 (the closing price of Republic Services, Inc.'s common stock on 08/22/2018). Administrative issue caused delay in receipt of payroll calculation after 08/24/2018 (Friday) filing deadline.

(3) Each Restricted Stock Unit represents the contingent right to one share of common stock of Republic Services, Inc.
