 - (5) Pursuant to anti-dilution provisions in AmTrust Financial Services, Inc.'s 2010 Omnibus Incentive Plan, 1,124 restricted stock units granted to Mr. Schlachter on May 21, 2010 and held on September 20, 2012 became 1,236 restricted stock units.
