Explanatory Note

This Amendment No. 1 on Form 8-K/A is being filed by Blueknight Energy Partners, L.P. (the “Partnership”) to revise Item 7.01, including Exhibit 99.1, of the Form 8-K filed by the Partnership on April 24, 2018 (the “Original Form 8-K”) for the purpose of changing “May 14, 2018” to “May 15, 2018” in (i) the first sentence of Item 7.01 and (ii) the second sentence of the introductory paragraph of the Press Release furnished as Exhibit 99.1 thereto, which has been corrected on Exhibit 99.1 to this Amendment No. 1. No other changes have been made to the Original Form 8-K.

Item 7.01. Regulation FD Disclosure.

On April 23, 2018, Blueknight Energy Partners, L.P. (the “Partnership”) issued a press release (the “Press Release”) announcing that on May 15, 2018, it will pay quarterly distributions of \$0.1450 per common unit, unchanged from the Partnership’s fourth quarter 2018 distribution, and \$0.17875 per preferred unit to its common and preferred unitholders of record as of the close of business on May 4, 2018. A copy of the Press Release is furnished as an exhibit to this Current Report.
