- (1) Each restricted stock unit granted on March 18, 2013 represents a right to receive one share of common stock and will cliff vest on March 18, 2018. Vested shares will be delivered to the reporting person within 90 days after the vesting date.
- (2) Includes 13,000 restricted stock units granted to Mr. Lampert that were previously reported on Table 2. Mr. Lampert intends to report future restricted stock unit grants on Table 1 as each restricted stock unit represents a contingent right to receive one share of General Cable Corporation stock upon vesting.
- (3) A portion of these shares are held in the General Cable Retirement Savings Plan as share equivalents and are valued at the market close price on March 18, 2013. The reporting person did not acquire any additional share equivalents since his last Form 4 filing.
