The value of the SMCA is payable in cash following the reporting person's termination of employment with the Issuer and its subsidiaries.
- (6) Options to buy 8,210 shares become exercisable on 02/15/2015 and options to buy 8,211 shares become exercisable on each of 02/15/2016 and 02/15/2017.
