On August 18, 2017, the Board of Directors (the "Board") of Ideal Power Inc., a Delaware corporation (the "Company"), determined that it was in the best interest of the Company to remove Bill Alexander as Chief Technical Officer and appoint him as Chief Technologist. Mr. Alexander is no longer deemed an "executive officer" within the meaning of Rule 3b-7 under the Exchange Act or an "officer" of the Company within the meaning of Rule 16a-1(f) under the Exchange Act. On August 21, 2017, pursuant to the Board's decision, Mr. Alexander and the Company executed an amendment to Mr. Alexander's employment agreement to reflect the change in position. As Chief Technologist, Mr. Alexander will focus on research and development, including development of the Company's B-TRANTM technology and innovations to its PPSATM technology.
