The 2018 results of operations will reflect a decrease in revenues of 41.1%, a decrease in gross profit of 17.7% and an increase in general and administrative expenses of 7.6%. The 2018 results of operations will also reflect a gain on foreign currency remeasurement of \$225,000 and an income tax expense of \$47,000 as compared to the 2017 results of operations which reflected a loss on foreign currency remeasurement of \$178,000 and an income tax benefit of \$751,000. The consolidated results of operations will not reflect any other significant changes.
