Even though no transaction has occurred, this fluctuation may result in an increase or decrease in the number of shares held since the last report filed by the reporting person.
- (2) SARs are exercisable upon vesting. Vesting occurs when the market price of the PolyOne common stock reaches pre-determined levels for three consecutive days as follows: 1/3 vest at a market price of \$9.84 per share; an additional 1/3 vests at a market price of \$10.73 per share; and the remaining 1/3 vests at a market price of \$11.63 per share.
