- On December 1, 2014, in connection with the closing of the transactions contemplated by the Contribution, Conveyance and Assumption Agreement, dated as of October 22, 2014, by and among the Issuer, Phillips 66 Partners GP LLC ("the General Partner"), Phillips 66 Company ("P66 Company") and Phillips 66 Pipeline LLC ("P66 Pipeline"), the Issuer acquired certain assets from P66 Company and P66 Pipeline, for aggregate consideration of approximately \$340 million. The consideration consisted of \$28 million in cash, the issuance of 1,066,412 common units of the Issuer to P66 Company, the issuance of 21,764 general partner units of the Issuer to the General Partner and the assumption by the Issuer of a 5-year, \$244 million note payable to a subsidiary of P66 Company.
- This Form 4 is filed jointly by Phillips 66 ("PSX") and P66 Company. P66 Company, a direct wholly owned subsidiary of PSX, owns all of the outstanding membership interests in the General Partner. Accordingly, the General Partner is an indirect wholly owned subsidiary of PSX. PSX may be deemed to indirectly own the securities of the Issuer directly held by the General Partner, but disclaims beneficial ownership except to the extent of its pecuniary interest therein. PSX may also be deemed to indirectly own the securities of the Issuer

directly held by P66 Company, but disclaims beneficial ownership except to the extent of its pecuniary interest therein.
