(1) Acquisition of IGT common stock on vesting and disposition of IGT restricted stock unit award.

The units vested on March 4, 2013.

The restricted stock units vest in three equal annual installments commencing on the earlier of (a) the first anniversary of the date of grant and (b) the date of the Issuer's annual meeting of stockholders. The first installment vested on March 1, 2011, the second installment vested on March 5, 2012, and the third installment vested on March 5, 2013.
