On June 7, 2006, Alabama Power Company (the "Company") entered into an Underwriting Agreement covering the issue and sale by the Company of \$150,000,000 aggregate principal amount of its Series JJ 6.375% Senior Notes due June 15, 2046 (the "Series JJ Senior Notes").
