Since the reporting owner's previous report, on May 20, 2004 the reporting owner transferred to himself, as trustee of a grantor retained annuity trust (GRAT), 656,345 shares of the issuer's common stock that were previously held directly. On April 15, 2005, the reporting owner substituted assets of equal value into the GRAT in exchange for 254,283 shares. As such, although the reporting owner's total ownership did not change, these 254,283 securities are now directly owned by the reporting owner rather than indirectly owned through the GRAT.
