Item 1.01 Entry into a Material Definitive Agreement.

On October 7, 2016, Avis Budget Group, Inc. and its subsidiaries, Avis Budget Holdings, LLC and Avis Budget Car Rental, LLC, as the Borrower, entered into a fourth amendment and restatement of the Third Amended and Restated Credit Agreement dated as of October 3, 2014, with JPMorgan Chase Bank, N.A., as Administrative Agent and the other lenders party thereto. Pursuant to this amendment, the term of the revolving facility was extended until 2021. In addition, the new credit agreement contains revised affirmative covenants, financial and other negative covenants and certain other revised terms.

The foregoing summary is qualified by reference to the terms of the Fourth Amended and Restated Credit Agreement, which is attached hereto as Exhibit 10.1 and is incorporated by reference herein.

Certain of the lenders party to the credit agreement, and their respective affiliates, have performed, and may in the future perform, various commercial banking, investment banking and other financial advisory services for Avis Budget Group, Inc., Avis Budget Car Rental, LLC and their subsidiaries for which they have received, and will receive, customary fees and expenses.
