#### 1. Plan Description

The Pacific Telesis Group Employee Stock Ownership Plan (the Plan) was established by the Pacific provisions of the Tax Reduction Act of 1975 as amended by the Tax Reform Acts of 1976 and 1986, to company's common stock to eligible employees. PTG is a wholly owned subsidiary of SBC Communication.

The Tax Reform Act of 1986 repealed the income tax credit on employee stock ownership plan contributions accrued after December 31, 1986. No contributions were made to the Plan beginning with the 1987 in the Plan on December 31, 1986 are eligible for participation in the Plan and continue to maint Employees who did not have a balance in the Plan at that time are not eligible to participate.

Although it has not expressed any intent to do so, SBC has the right under the Plan to terminate provisions of ERISA. In the event that the Plan is terminated, subject to the conditions set for the net assets be distributed to participants in amounts equal to their respective interests in s

#### 2. Summary of Significant Accounting Policies

The fair value of SBC common stock is determined on the basis of the closing price per share on to official close of the New York Stock Exchange. Temporary cash investments are valued at cost, where Purchases and sales of securities are reflected as of the trade date. Dividend income is recognized interest earned on investments is recognized on the accrual basis.
