(1) Includes a target number of 32,108 performance restricted stock units granted under the Amended and Restated EMC Corporation 2003 Stock Plan, which units are subject to forfeiture upon certain events. The performance restricted stock units will vest only in the event that 2015 performance targets approved by the Leadership and Compensation Committee (the "Committee") have been met. Depending on the level of achievement for each of the performance metrics, a maximum of 150% of the target number of performance restricted stock units may vest. The Committee expects to determine the extent to which the performance targets have been met in 2016, and one-third of the applicable number of units will vest in 2016, one-third will vest on February 1, 2017 and one-third will vest on February 1, 2018.

(2) Includes 22,945 restricted stock units granted under the Amended and Restated EMC Corporation 2003 Stock Plan, which units are subject to forfeiture upon certain events. The forfeiture restrictions on the units may lapse on or before the fifth anniversary of the date of grant based on achievement of performance targets approved by the Committee.
