The market value of Tech Data stock reached \$56.66 per share after the vesting period, attaining the award's \$20 maximum cap per share, (1) therefore, in accordance with the grant agreement, the vested shares were automatically exercised. The net shares received represent the maximum value less any tax liability.

(3) Maximum value stock-settled stock appreciation right (MVSSAR) granted on 10/02/2006 at an exercise price of \$36.66 per share under the Amended and Restated 2000 Equity Incentive Plan of Tech Data Corporation of which 25% is exercisable on 10/02/2007 and on each of the subsequent anniversaries. Each MVSSAR is granted with a \$20 predetermined cap on the realizable value per share.
