In October 2007, we issued an aggregate of 6,750,000 common shares to four accredited investors upon the conversion of \$6,075 in callable secured convertible notes.

In October 2007, we issued an aggregate of 15,267,170 common shares to four accredited investors upon the conversion of \$13,740 in callable secured convertible notes.

In November 2007, we issued an aggregate of 14,500,000 common shares to four accredited investors upon the conversion of \$10,150 in callable secured convertible notes.

In November 2007, we issued an aggregate of 15,267,170 common shares to four accredited investors upon the conversion of \$10,687 in callable secured convertible notes.

In November 2007, we issued an aggregate of 21,000,000 common shares to four accredited investors upon the conversion of \$14,700 in callable secured convertible notes.

In addition to representations by the above-referenced persons, we have made independent determinations that all of the above-referenced persons were accredited or sophisticated investors, and that they were capable of analyzing the merits and risks of their investment, and that they understood the speculative nature of their investment. Furthermore, all of the above-referenced persons were provided with access to our Securities and Exchange Commission filings.
