This prospectus supplement relates to the resale by the selling securityholders of zero coupon convertible subordinated notes due 2020 of Sanmina Corporation and the shares of common stock, par value of \$0.01 per share, of Sanmina Corporation issuable upon the conversion of the notes.

This prospectus supplement should be read in conjunction with the prospectus dated December 19, 2000 and the prospectus supplements dated January 12, 2001, January 31, 2001, March 2, 2001, April 6, 2001 and April 23, 2001 which are to be delivered with this prospectus supplement. All capitalized terms used but not defined in the prospectus supplement shall have the meanings given them in the prospectus.
