- On 6/11/13, Veramark Technologies, Inc. (the "Company"), Hubspeke Holdings, Inc. ("Hubspeke") and TEM Holdings, Inc., a wholly-owned subsidiary of Hubspeke ("Merger Sub") entered into an Agreement and Plan of Merger (the "Merger Agreement")
- (1) providing for a cash tender offer to acquire all of the outstanding shares of common stock of the Company for \$1.18 per share, to be followed by a merger of Merger Sub with and into the Company, with the Company to continue as the surviving corporation. These shares were accepted in connection with the tender offer on 7/16/13.
 - (2) Pursuant to the terms of the Merger Agreement, as of the effective time of the merger (7/22/13), this option was cancelled and Mr. Bouk became entitled to receive a cash payment in an amount equal to the difference between \$1.18 and the exercise price per share under the option multiplied by the number of shares covered by the option.
