(2) Represents shares held by THHC, L.L.C., a member-managed Delaware limited liability company controlled by F.L.P. Trust #11. On August 31, 2015, Maroon Private Trust Company, LLC was appointed as trustee of F.L.P. Trust #11. Maroon Private Trust Company, LLC is a manager-managed South Dakota limited liability company, the sole member of which is Maroon Trust. The Reporting Person is the trustee of Maroon Trust and in such capacity may, for the purposes hereof, be deemed to beneficially own the shares held by THHC, L.L.C.
