- (1) 3,490 restricted shares are held in an account at Computershare, which have upcoming vesting dates.
- (2) A total of 79,464 shares are beneficially owned by Dr. Brody; 48,400 are held jointly with his spouse; 12,705 are held in street name; and 18,359 are held in an account at Computershare.
- (3) Shares held in a master account of Financial Planning Analysts over which Dr. Brody has no voting authority, but has dispositive power.
- (4) Dr. Brody exercised 1,539 stock options at \$3.46 per share, and sold at \$25.24 per share.
- (5) Dr. Brody exercised 661 stock options at \$3.46 per share, and sold at \$25.35 per share.
- (6) 11,400 stock options were granted of which 5,667 are currently exercisable.
