(1) Restricted shares granted on April 2, 2012 to the Reporting Person under the Issuer's 2008 Incentive Stock Plan, as amended, pursuant to a Restricted Shares Agreement. Under the terms of the Restricted Shares Agreement, the restricted shares vest on the earlier of one year from the date of grant or upon the Reporting Person ending his service as a director of the Issuer, subject to the terms thereof.

(2) Effective January 1, 2012, as a result of an amendment to a certain management agreement with Steel Partners Holdings L.P., Warren G. Lichtenstein ceased to have the power to vote and dispose of securities owned directly by SPH Group Holdings LLC ("SPHG Holdings"). Accordingly, Mr. Lichtenstein is no longer deemed to beneficially own the securities of the Issuer owned directly by SPHG Holdings.

(3) The Reporting Person is also a member of a Section 13(d) group that owns more than 10% of the Issuer's outstanding common stock.
