- On October 28, 2016, the issuer declared a cash dividend of \$0.12 per share of common stock, payable December 23, 2016 to all shareholders of record on December 9, 2016 (the "Dividend"). In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, October 14, 2013, October 14, 2013, as amended, January 2, 2014, January 2, 2015 and January 4, 2016, 24, 15, 6, 26, 64 and 79 additional shares of restricted stock were received by the reporting person in connection with the Dividend. The additional shares of restricted stock will vest as follows: 24 shares in even increments over 2 years beginning January 2, 2017, 15 shares in even increments over 5 years beginning October 14, 2019, 6 shares in even increments over 2 years beginning November 30, 2017, 26 shares in even increments over 3 years beginning January 2, 2017, 64 shares in even increments over 4 years beginning January 2, 2017 and 79 shares in even increments over 5 years beginning January 4, 2017.
