(e) The Registrant approved an amendment and restatement of the Employment Agreement between Mr. Vito S, Pantilione, President and CEO of the Registrant and Parke Bank, a wholly owned subsidiary of the Registrant. The agreement, as amended and restated, includes a new three year term ending December 31, 2010, clarification that any severance payments related to a change in control transaction will be limited to amounts that are deductible in accordance with Section 280G of the Internal Revenue Code of 1986, as amended ("Code") and certain provisions added in conformity with Section 409A of the Code. The Registrant guarantees the Bank's payment obligations under the agreement. A copy of the Employment Agreement, as amended and restated is filed as Exhibit 10.1 hereto and incorporated by reference herein. In addition, the Registrant and Parke Bank approved Management Change in Control Severance Agreements between the Registrant, Parke Bank and four of its named executive officers (Elizabeth Milavsky, Senior Vice President, Robert Kuehl, Senior Vice President, Paul Palmieri, Senior Vice President, and David Middlebrook, Senior Vice President). The form of such Management Change in Control Severance Agreement applicable to these four named executive officers is filed as Exhibit 10.2 hereto and is incorporated by reference herein.
