On September 25, 2008, the Registrant determined that in connection with the action taken by the United States Treasury Department and the Federal Housing Finance Agency with respect to the Federal National Mortgage Association (Fannie Mae) and the Federal Home Loan Mortgage Corporation (Freddie Mac) and the related impairment in value of the preferred stock issuances of Fannie Mae and Freddie Mac, it would need to record an other-than-temporary impairment in the third quarter of 2008 and take a non-cash after-tax charge to earnings of \$459 thousand for its investments in perpetual preferred securities issued by Fannie Mae and Freddie Mac. These securities were included in securiti available for sale at the end of the second quarter 2008 at a combined carrying value of \$512 thousand.
