ANNOUNCEMENT REGARDING EUROASIA'S LOAN AGREEMENT

Euroasia Telecommunications Holdings BV ("Euroasia") is a group company with 55% shareholding by Turkcell and 45% by System Capital Management. Euroasia is 100% shareholder of Astelit LLC ("Astelit"), a company operating in Ukraine.

In order to provide financing to Astelit through a shareholder loan, in 2005 Euroasia borrowed USD150 million from banks with due date of March 30, 2012 under full Turkcell guarantee.

Since Euroasia does not have the necessary funds to repay the loan and as Turkcell Board has not taken a decision to extend the guarantee as of today, Euroasia breached the loan agreement on March 30, 2012. Therefore, Turkcell will be obliged to make the related loan repayment on or before April 6, 2012 as a result of the given guarantee.
