**TELECOM ITALIA: 19.9% SKY EQUITY STAKE**

**DISPOSED OF TO NEWSCORP**

*Milan, September 28, 2004* - Telecom Italia today signed a deal with NewsCorp to dispose of its 19.9% equity interest in Sky Italia.

NewsCorp is to pay **88 million euros** for the shareholding to Telecom Italia SpA, corresponding to a capital gain of **31.4 million euros** over the book value as at June 30, 2004. Taking account of writedowns undertaken in the first half of this year, the transaction will have a substantially neutral effect on Telecom Italia's operating accounts.

Today's deal enables Telecom Italia to focus more closely on its core business.

- the impact of regulatory decisions and changes in the regulatory environment;
- the impact of the slowdown in Latin American economies and the slow recovery of economies generally on the international business of the Telecom Italia Group focused on Latin America and on its foreign investments and capital expenditures;
- the continuing impact of rapid changes in technologies;
- the impact of political and economic developments in Italy and other countries in which the Telecom Italia Group operates;

- the impact of fluctuations in currency exchange and interest rates;
