**TELECOM ITALIA: CONSOB ALERTED AGAINST MARKET DISTURBANCE AND IN DEFENCE OF SHAREHOLDERS**

*Milan, 8 August 2006* Telecom Italia, in the light of the continual and repeated dissemination by the press of information that is untrue and misleading in relation to the Group's financial situation and the hypothesis that the network might be hived off, states that it will take every action, as it recently has, to protect the company and shareholders. In particular, it has called upon CONSOB, the Italian market Authority, to prevent the continuing dissemination of news reports which could cause serious market disturbance.

With regard to the hiving off of the fixed-line network, Telecom Italia wishes to underline that this hypothesis has never had the least echo at the government level, among Italian Authorities or at the European Commission level.

Such an initiative could not be realized if not with the agreement of the company, which legitimately owns the network, and which, it should be recalled, operates in a free market under licence and not through government concession.

- the impact of regulatory decisions and changes in the regulatory environment;
- the impact of the slowdown in Latin American economies and the slow

recovery of economies generally on the international business of the Telecom Italia Group focused on Latin America and on its foreign investments and capital expenditures;

- the continuing impact of rapid changes in technologies;
- the impact of political and economic developments in Italy and other countries in which the Telecom Italia Group operates;
- the impact of fluctuations in currency exchange and interest rates;
- Telecom Italia's ability to continue the implementation of its 2002-2004 Industrial Plan, including the rationalization of its corporate structure and the disposition of Telecom Italia's interests in various companies;
- the ability of the Telecom Italia Group to successfully achieve its debt reduction targets;
- Telecom Italia's ability to successfully roll out its UMTS networks and services and to realize the benefits of its investment in UMTS licenses and related capital expenditures;
- Telecom Italia's ability to successfully implement its internet strategy;
