CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 49,050,000 shares or 8.8% of the 555,908,108 shares of Series A Shares believed to be outstanding.

Emerging Markets Growth Fund, Inc., an investment company registered under the Investment Company Act of 1940, which is advised by Capital International, Inc., is the beneficial owner of 48,825,000 shares or 8.8% of the 555,908,108 shares of Series A Shares believed to be outstanding.
