CELLCOM ISRAEL LTD. ANNOUNCES DISSMISAL OF PURPORTED  
CLASS ACTION FILED AGAINST THE COMPANY

Netanya, Israel – April 2, 2014 – Cellcom Israel Ltd. (NYSE: CEL) (TASE: CEL) (hereinafter: the "Company") announced that further to the Company's report dated November 2011 regarding a purported class action filed against the Company alleging that the Company raised tariffs for business customers unlawfully and in violation of its agreements with them, the purported class action was dismissed with prejudice.

The total amount claimed from the Company, had the lawsuit been certified as a class action, was estimated by the plaintiffs to be at least hundreds of millions of NIS.
