**ICICI Bank's US\$ 500 million International Bond offering**

ICICI Bank (NYSE: IBN), acting through its DIFC (Dubai) branch, successfully priced an issuance of 10 year fixed rate notes of US\$ 500 million. The notes carry a coupon of 3.80% and were offered at an issue price of 99.728.
