**Upside return amount:**  $\$1,000 \times$  the underlying return of the worst performing underlying  $\times$  the upside participation rate

**Upside participation rate:** At least 155%\*

**Absolute underlying return:** For each underlying, the absolute value of its underlying return

**Buffer amount:** 30%

For each \$1,000 stated principal amount security you hold at maturity:

- If the final underlying value of the worst performing underlying is **greater than or equal to** its initial underlying value:

$\$1,000 +$  the upside return amount

- If the final underlying value of the worst performing underlying is **less than** its initial underlying value by an amount **less than or equal to** the buffer amount:

$\$1,000 + (\$1,000 \times$  the absolute underlying return of the worst performing underlying)

**Payment at Maturity:**

- If the final underlying value of the worst performing underlying is **less than** its initial underlying value by an amount **greater than** the buffer amount:

$\$1,000 + (\$1,000 \times$  the underlying return of the worst performing underlying) + \$300

### Selected Risk Considerations

If the worst performing underlying depreciates by more than the buffer amount, the absolute return feature will no longer be available and you will lose 1% of the stated principal amount of the securities for every 1% by which that depreciation exceeds the buffer amount.
