**SCHEDULE 13G**

This Amendment No. 1 to the Schedule 13G (this Amendment) relates to shares of Common Stock, par value \$0.01 per share (Common Stock), of Meta Financial Group, Inc., a Delaware corporation (the Issuer), and is being filed on behalf of (i) Teton Capital Partners, L.P. (the Fund), a Texas limited partnership, (ii) Ancient Art, L.P. (Ancient Art), a Texas limited partnership, as the investment manager to the Fund, (iii) Whitney, L.P. (Whitney), a Texas limited partnership, as the general partner of the Fund, (iv) Trango II, L.L.C. (Trango), a Texas limited liability company, as the general partner of both Ancient Art and Whitney, and (v) Quincy J. Lee, the principal of Trango (the persons mentioned in (ii), (iii), (iv) and (v) above are referred to herein as the Teton Management Group, and, collectively with the Fund, the Reporting Persons). All shares of Common Stock are held by the Fund.

These percentages were calculated by dividing (i) 41,667, the number of shares of Common Stock held by the Fund, by (ii) 3,112,463, the number shares of Common Stock issued and outstanding as of December 10, 2010, as reported in the Issuer's most recent Form 10-K filed with the Securities and Exchange Commission on December 13, 2010.
- (c) The Fund has the sole power to vote and dispose of the 41,667 shares of Common Stock it holds. The Teton Management Group has the shared power to vote and dispose of the 41,667 shares of Common Stock held by Fund.
