- (1) On October 29, 1997, the reporting person was granted an option to purchase 49,580 shares of common stock. The option vests seven years from the date of grant or in five equal annual installments subject to the Company's satisfaction of certain performance criteria each year. After the transactions reported above, no options are vested under this award.
- (2) On May 19, 2000, the reporting person was granted an option to purchase 12,000 shares of common stock. The option vests in three substantially equal annual installments. After the transactions reported above, 4,080 options are vested under this award.
