This statement is filed pursuant to Rule 13d-2(b) with respect to the common stock (the "Common Stock") of NetSol Technologies, Inc. beneficially owned by the Reporting Person specified herein as of December 31, 2007 and amends and supplements the Schedule 13G filed by the Reporting Person on June 23, 2006, as amended on February 12, 2007, July 12, 2007 and July 16, 2007 (the "Schedule 13G").

ITEM 4. OWNERSHIP.

Provide the following information regarding the aggregate number and percentage of the class of securities of the issuer identified in Item 1.

(a) Amount beneficially owned:

Subject to the Ownership Limitation (defined below), The Tail Wind Fund Ltd. (Tail Wind) owns a total of 2,935,821 shares of Common Stock, including (i) 1,269,155 shares of Common Stock held, (ii) 1,060,606 shares of Common Stock issuable upon conversion of \$1,750,000 in liquidation preference of the issuer's Series A 7% Cumulative Convertible Preferred Stock (Preferred Stock), (iii) 303,030 shares of Common Stock issuable upon exercise of warrants issued to Tail Wind on June 29, 2007, and (iv) 303,030 shares of Common Stock issuable upon exercise of warrants issued to Tail Wind on October 29, 2007 (together with the warrants issued on June 29, 2007, the Warrants).

In accordance with Rule 13d-4 under the Securities Exchange Act of 1934, as amended, because the number of shares of Common Stock into which the Reporting Person's Preferred Stock and Warrants are convertible and exercisable is limited, pursuant to the terms of such instruments, to that number of shares of Common Stock which would result in the Reporting Person having beneficial ownership of 9.9% of the total issued and outstanding shares of Common Stock (the "Ownership Limitation"), the Reporting Person disclaims beneficial ownership of any and all shares of Common Stock that would cause the Reporting Person's beneficial ownership to exceed the Ownership Limitation.

Therefore, in accordance with the Ownership Limitation, Tail Wind, based upon 25,030,443 shares of common stock outstanding, beneficially owns 2,610,841 shares of Common Stock and disclaims beneficial ownership of 324,980 shares of Common Stock.

(b) Percent of class:

Tail Wind's beneficial ownership of 2,610,841 shares of Common Stock constitutes 9.9% of all the outstanding shares of Common Stock, based upon 24,877,766 shares of Common Stock outstanding as of November 5, 2007 as reported by the issuer, plus 152,677 shares of Common Stock issued to Tail Wind since such date, plus the number of shares underlying the Preferred Stock and Warrants held by Tail Wind.
