- (2) The reporting price is the weighted average sale price per share for 39 transactions in which the sale prices range from \$18.79 to \$19.16 per share. The Reporting Person undertakes to provide full information regarding the number of shares sold at each separate sale price upon request of the Securities and Exchange Commission staff, the issuer or any security holder of the issuer.

- (3) The reporting price is the weighted average sale price per share for 55 transactions in which the sale prices range from \$18.27 to \$19.08 per share. The Reporting Person undertakes to provide full information regarding the number of shares sold at each separate sale price upon request of the Securities and Exchange Commission staff, the issuer or any security holder of the issuer.

- (4) After giving effect to the transactions reported in this Form 4, Ms. Clark directly beneficially owns 100 shares of common stock with 37,402 shares indirectly through her spouse and 1,132,412 shares indirectly through Smart Stuff, Inc. of Build-A-Bear Workshop, Inc. Ms. Clark is the president and sole stockholder of Smart Stuff, Inc.
