- (2) Each unit represents a right to receive one share of Bemis Common Stock upon vesting.
- (3) Settlement under Bemis Time Accelerated Restricted Stock Appreciation Program (TARSAP) exempt under Rule 16b-3. Settlement of units was made on January 2, 2013 with 5,368 shares withheld for taxes, resulting in delivery of 7,632 shares to Reporting Person.
