**Item 5. Other Events And Regulation FD Disclosure**

On May 16, 2003, IDACORP announced the settlement with FERC of issues surrounding activities between IDACORP affiliates, Idaho Power Company and IDACORP Energy. Please refer to the press release filed as an exhibit hereto.

Any such forward-looking statements should be considered in light of such factors and others noted in the Companies' Form 10-K for the year 2002 and the Quarterly Report on Form 10-Q for the quarter ended March 31, 2003, and other reports on file with the Securities and Exchange Commission.
