On November 12, 2015, Net1 issued a press release which announced that it had received a written notice from the Serious Economic Offences Unit of the South African Police Service s Directorate for Priority Crime Investigation (the Hawks). The Hawks stated that the cases brought before it had been investigated and brought before two separate prosecutors for decisions.
