#### Item 8.01 Other Events.

On April 10, 2017, Citi Trends, Inc. (the Company) issued a press release announcing that the Company s board of directors (Board) has authorized an expanded capital return program, which includes the repurchase of up to \$25 million of its common stock, a 33.3% increase in the Company s quarterly dividend, from \$0.06 to \$0.08 per share, maintaining a minimum cash balance of \$80 million, and a commitment to return excess cash to the Company s stockholders through additional dividends and buybacks. The increased dividend will begin with the Company s second quarter dividend to be paid in June 2017, consistent with the Company s typical timing for its second quarter dividend, subject to Board approval.
