On September 26, 2018, Amendment No. 1 (the <u>AAP Amendment</u>) to the Eighth Amended and Restated Limited Partnership Agreement of Plains AAP, L.P. (the <u>AAP LP Agreement</u>) was executed by its general partner, Plains All American GP LLC, to revise the definition of the term Permitted Transfer thereunder to allow any existing owner of less than 0.50% of the Partnership Group Interests (as defined in the AAP LP Agreement) to make transfers of their Partnership Group Interests (i) to certain family members, trusts and partnerships if such existing owner is a natural person, and (ii) to beneficial owners of such existing owner if such existing owner is not a natural person. Any such transfers will require approval of the board of directors of PAA GP Holdings LLC.

The foregoing description is qualified in its entirety by reference to the full text of the AAP Amendment, which is filed as Exhibit 3.1 hereto and is incorporated herein by reference.
