Under the terms of the Plan, each nonemployee director may elect, prior to the calendar year in which fees are earned, to defer all or a portion of his or her annual retainer, and committee and board chairman's fees
- (1) into one or more investment options available under the Plan, including the OMNOVA Solutions Common Shares Fund. Phantom shares are credited to a director's account based on the number of OMNOVA common shares that could have been purchased with the amount deferred at the closing price per share on the New York Stock Exchange on the date that the director's fees would otherwise have been payable to him.
  - (2) Each phantom share represents the right to receive the cash value of one OMNOVA Common Share.
