This Statement on Schedule 13D (this "Statement") relates to shares of auction rate preferred securities ("ARPS") of Pioneer High Income Trust (the "Issuer"). This Amendment is being filed by the Reporting Persons as a result of the Issuer's redemption of its shares. The Issuer's principal executive offices are located at 60 State St., 13th Floor, Boston, MA 02109.

All series of ARPS issued by the Issuer that vote together as a single class are treated as one class.

Item 2. Identity and Background

(a) This Statement is being filed on behalf of each of the following persons (collectively, the "Reporting Persons"):
i. Bank of America Corporation ("BAC")
ii. Bank of America, N.A. ("BANA")
iii. Blue Ridge Investments, L.L.C. ("Blue Ridge")

This Statement relates to the ARPS held for the account of BANA and Blue Ridge.

- (c) BAC, through its wholly-owned subsidiaries, BANA, Blue Ridge and Merrill Lynch, is engaged in providing a diverse range of financial services and products. Since settlements with the Securities and Exchange Commission and certain state agencies in 2008, Merrill Lynch and certain predecessors have worked with their customers and issuers of auction rate preferred securities market. This has included purchasing auction rate preferred securities from their customers and working with issuers so that they are able to redeem outstanding auction rate preferred securities. BAC's efforts to work with issuers continue and may include working with the Issuer in the future.
- (d) Other than as set forth on Schedule II, during the last five years, none of the Reporting Persons, and to the best knowledge of the Reporting Persons, none of the Listed Persons, have been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) or was a party to a civil proceeding of a judicial or administrative body of competent jurisdiction as a result of which such person was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws, or finding any violation with respect to such laws.

state securities laws, or finding any violation with respect to such laws.
