Shares reported herein for Mr. Kolchinsky represent the above-referenced shares of Common Stock (including additional shares of Common Stock issuable upon the exercise of certain Series A Shares and Warrant Shares) reported for Capital, for which Mr. Kolchinsky serves as the manager.
