In accordance with Rule 17g-1(g) of the Investment Company Act of 1940, each of the registrants listed on Attachment A hereby files the following documents with the Commission:

1. Bond No. 87002115B (the “Bond”) issued by the ICI Mutual Insurance Company of Washington, DC the amount of \$38,000,000 covering the period July 31, 2015 through July 31, 2016 (**EXHIBIT 99-1**);

2. A certified copy of resolutions adopted by a majority of the Trustees who are not “interested persons” of each of the registrants, at a meeting held on July 14, 2015, approving the amount, type, form and coverage of the Bond and the portion of the premium to be paid by each Registrant (**EXHIBIT 99-2**);
